The implementation of the protocol of Council's 18th Session, the State Service for Supervision and Regulation in the Transport sector changed the amendments to the Decree of the Government of the Republic of Tajikistan #779 from December 29, 2006 "On establishment of rules for Transport Vehicles with overweight and volume" and currently is under implementation. There are 22 weighing points in the country. In 2018 during 10 months there were disclosed 660 cases of violation with total penalty amount of 1650 thousand somoni and 36 cases with 2000 tones overweight, which was moved to another vehicle. The Action Plan of mentioned above events is being implemented in accordance with international best practices for simplifying the state regulation on business activity, including registration of business, licensing, connection to electricity, taxation and tax administration, property registration, access to credit, international trade, ensuring the implementation of the contract and solving the issue of liquidity.

State Committee on Investments and State Property Management jointly with the Secretariat of the Consultative Council organized a number of working meetings on issues of prevention of repeated audit, development of sectoral reports and analyzes, high level professional training and recommendations of local and international experts in coordination with national bodies and agencies, private sector and development partners.

## **Ministry of Finance**

In order to improve the country's position in international assessments, the Government of the Republic of Tajikistan decree # 354 from August 23, 2006 adopted Tax Program for Tax Improvement for the years 2011 - 2019 for simplification of registration procedures and the reform of tax system. In particular, from January 1, 2018 the direct order of the state registration of legal entities and individual entrepreneurs was established on the website of the Tax Committee, which provides for the opportunity to visit the state registration agency only to receive original copy of the document.

At the same time this year the procedure of online business registration and tax payment using 'National card' and MASTERCARD simplified whole system for business entities.

In the framework of Inter-Agency Working Group under the State Committee on Investments and State Property Management, the amendments and additions to the Tax Code and the Customs Code have been developed and adopted. In total there are 30 incentives aimed on improving of the investment and business climate.

In particular, changes and amendments included taking decision to the benefit of taxpayer in the case of dues and (or) violation of the Tax code or the absence of the necessary provisions for regulating tax relations, reducing the number of inspections, security of legal interest of business entities.

## National Bank of Tajikistan

In August 2017, the rating company S & P rated Tajikistan as "B-B with the prospect of sustainable development" and the Moody's rating of "V3" with the prospect of sustainable growth. The S & P did not change the indicators on August 24th and on October 30, 2018 it is expected that the Moody's rating agency will visit Tajikistan to rate the entrepreneurship climate.

**Barki Tojik.** In the field of "Energy Loss Reduction", there are more international companies offering advisory services than domestic companies offering same services, but from the financial side the cost for international consulting company is much higher.

Executive office of the state government in Norak. Project implementation unit "Management of Infrastructure Projects in Nurek "noted that in the framework of the implementation of state investment projects in the electricity sector, there are 3 international consulting companies and 1 local company operating.
