-Working Group has been set up to work with other relevant ministries and agencies to improve Tajikistan indicators in Doing Business report. A number of videoconferences have been conducted with Doing Business team in regard with starting a business, getting permits for construction, getting electricity, taxation and trading across borders procedures. Awareness of the relevant public bodies has been raised on methodology of the Doing Business report as well as comprehensive information on reforms' achievements have been prepared and discussed with World Bank experts in regard with simplification of business regulation procedures.

As a result, Tajikistan has improved its position totally for 5 positions in 2018 getting 123 place, comparing to the 128 of last year. Particularly it has been achieved due to improvement of "Starting a Business" indicator by 28 positions through the raising the revenue threshold for mandatory VAT registration, elimination of VAT registration procedure and cutting 11 days for business registration; raising "Getting Permits for Construction" indicator by 26 position through the elimination of separate procedure on request and obtain technical conditions from Barki Tojik and procedure on receive a periodic inspection from the State Body on Automobile Activity Management that reduced the time for getting permit for 60 days; "Registering Property" indicator by 7 position through the elimination of need to register the salepurchase agreement at the municipal office; "Taxation" indicator by 8 position through the reduction of payments for 6 per year and time for 34 days; "Trading across Borders" indicator by 3 positions through the improvement of international trade infrastructure within CAREC cooperation.

- -Electronic Registry of Inspections of the public bodies was developed.
- -Consultative Council developed a website for the entrepreneurs to check its current inspection status http://ijozat.iktmaster.ru/

Committee on Youth Affairs, Sport and Tourism together with other relevant ministries and agencies take purposeful measures on tourism development, full implementation of the adopted Action Plan of Government on Improvement of Investment Climate in Tourism Sector and indicators of the National Concept on Tourism Development, preparing experienced professionals and providing modern services to tourists and in general presentation of Tajikistan as a tourism destination country.

- Participation in the ITB Berlin for 10 years to present Tajikistan as tourism destination country;
- Participation in International Tourism Exhibition in Moscow for 2 years to present Tajikistan as a tourism destination country;
- Modern relevant literature has been purchased and submitted free of charge for 10 high and secondary education institutions preparing tourism professionals;
- In cooperation with high education institutes favorable conditions have been provided to cover students with vocational training.
- In 2017 British Magazine Wanderlust Travel has published ranking of countries in which Tajikistan got 4th position among the countries with the simplest visa procedures.
- In 2016 World Tourism Organization included Tajikistan to the list of 10 countries most attractive for tourism.

Customs Service, Border Troops Main Department of the State Committee of National Security, Ministry of Transport together with the country's international airports to introduce international norms and requirements of arrival and departure of guests at international airports, other borders and customs crossing points as well as to submit results to the Government of the country within a month.

Has been implemented

Ministry of Transport has developed "Rules on arrangement of servicing to international passengers in Tajikistan airports" together with other relevant agencies that currently is under the consideration of ministries. Rules envisage collaboration of all relevant bodies on ensuring custom, borders, migration, phytosanitary, carantin, veterinary and aviation security of flights which implementation is obligatory for all services, agencies, legal entities and individuals relating to servicing to international passengers of Tajikistan airports.

Ministry of Foreign Affairs has developed and implements a Program on "Visa and Border Management" approved by Decree of Government dated June 13, 2016, #405 "On Arrangement of Information Electronic System for Getting Tajikistan Visa and Introduction of Tajikistan E-visa for foreign citizens".

12 cross-borders point (airports of Dushanbe, Khujand, Kulob and Madaniyat, Fotehobod, Panji Poyon, Dusti, Patar, Guliston, Qushtegirmon and Ruzvay and Tem of GBAO) have been connected to the Single Unified Network as well as equipped with modern information
