In this regard, important reforms have been implemented, the Republic of Tajikistan is a member of the World Trade Organization and the New York Convention on the Recognition of Foreign Arbitral Awards and Hague Convention has been ratified, that contributed for attracting



foreign investments into the national economy.

Current legislation defines 60 types of guarantees and tax and customs privileges.

In particular, regarding the protection of private property, the

inviolability of economic activity, as well as additional privileges strategic economy sectors, such as the construction of hydroelectric power plants, aluminum, cotton and other agricultural products, to create a unified legal system among domestic and foreign investors.

The existing laws of the country, almost all forms of participation of investors in the implementation of trade and investment projects through the creation of joint stock companies and limited liability companies, depending on the industry to ensure their interests through investment

agreements, production sharing agreement. concession agreement or a public private partnerships trough (BOT) build-operatetransfer methods or in other "Construction words Management Transfer -Build-Own-(VOO) and Operate.



Considered measures in the field of regulation of investment and business environment, contributed on better indicators in "Doing Business" in the annual Report of the World Bank and the years 2010, 2011 and 2014 to be in the top ten reformers.
