In particular, presentations were made on the results of the analysis of the impact of the COVID-19 pandemic on small

and medium businesses in Tajikistan, the draft "State Support and Private Sector Development Program in the Republic of Tajikistan for 2021-2030", corporate governance and other relevant topics.

After the speeches and presentations, there was an exchange of views between the participants.

It was expressed with confidence that the representatives of the private sector, entrepreneurs and investors will make efforts and contribute to the development of domestic production, the production of more importsubstituting and export-oriented products, providing the domestic market with competitive products.
