The results were presented during the meeting under the First Deputy Prime Minister on April 3, 2019
- In May-June, 2019 representatives of the Investment Committee for the first time participated at the OECD Investment Promotion Agencies Survey. The main objective was to receive experience of Eurasian countries in investment promotion, existing mechanisms, statistics analysis
- The Investment Committee jointly with the Secretariat of the Consultative Council developed monitoring table for analysis and tracking the results of 10 international assessment reports
- On April 4, 2019 there was conducted an interdepartmental meeting under the Investment Committee for discussion of the results of annual US State Department report on investment climate in Tajikistan. The issues described in the report were allocated to respective government ministry and agencies. The result of the meeting was submitted to the First Deputy Prime Minister of the Republic of Tajikistan
- The Standard& Poor's rating agency published the annual report on August 2019 and Tajikistan's the rate is B-/B with sustainable development outlook. In the Moody's Investors Service country's rate is B3 with negative outlook for 2019. As the result of cooperation between NBT in July and November 2019 experts of these rating agencies visited the Republic of Tajikistan to meet with relevant government bodies for further discussion of assessment process.
- On January 23, 2020, the International EITI Board recognized Tajikistan significant progress overall in implementing the EITI 2016 Standard, and thus the country's status was renewed. The Board commends Tajikistan for using the EITI to provide a better overview of the country's extractive sector and to enable stakeholders to participate in more informed discussions on natural resource management. The Board recommends Tajikistan to establish a clear legal framework for licensing processes, to continue to improve disclosure of information regarding state-owned enterprises, social expenditures and quasi-fiscal expenditures, to work in the field of

Tajikistan should also ensure that the EITI reporting process documents the impact and results of EITI implementation.

#### 3. Under implementation

- The issues of local and foreign investors and improvement of business and investment climate were reviewed during the first Intersession Meeting of the Council (more details in instruction points 1 and 10)
- In accordance with NBT statistics in January October 2019 there were 7,5 bln Tajik Somoni credited to local entrepreneurs, which is 24,1% more comparing with same period in 2018, where 3 bln Tajik Somoni were allocated to manufacturing entreprises.
- The Action Plan of 300 days of reform was approved by the Government of the Republic of Tajikistan on March 2, 2019. Following steps were completed during implementation of the Action Plan:
  - The Tax Committee of the Republic of Tajikistan submitted the draft amendments to the Tax Code to abolish 1% income tax for enterprises to ensure dercease in tax burden adopted by the Government dated January 2, 2020, No1676
  - The Tax Committee drafted amendments to the Law "On state registration of legal entites and individual entrepreneurs" and Law "On state duty" have been adopted dated January 2, 2020, #1680 and #1681. In accordance with amendment business entities register themselves with "Single Window" on state registration of business entities for free without payment of state fee for registration.
  - The amendment to the "Regulation of entrepreneurs holding patent or tax certificate" was approved on November 30, 2019. Starting from January 1, 2020 the amendment abolishes all taxes and registration fees for entrepreneurs manufacturing goods listed in the amendment
  - The Ministry of Finance proposed to include the silk production and related operations to the list of activities that are free of any taxes. Currently the proposal is being reviewed by ministry and departments
  - The draft amendments to the Tax Code of the Republic of Tajikistan on extention of the period of simplified taxation (7% VAT) for constructional activity was

approved on July 19, 2019.
