SEMINAR ON STRENGTHENING COOPERATION BETWEEN SECRETARIATS OF THE CONSULTATIVE COUNCIL ON IMPROVEMENT OF INVESTMENT CLIMATE UNDER THE PRESIDENT OF THE REPUBLIC OF TAJIKISTAN AND REGIONAL COUNCILS

On July 18, 2014 in Dushanbe, Secretariat of the Consultative Council on Improvement of Investment Climate under the President of the Republic of Tajikistan jointly with the State Committee on Investments and State Property Management of the Republic of Tajikistan held a seminar on strengthening cooperation between Secretariats of the Consultative Council on Improvement of Investment Climate under the President of the Republic of Tajikistan and regional councils on improvement of investment and business climate in provinces, cities and districts of the republic.

Round Table was opened with an opening speech of Head of Secretariat of the Consultative Council on Improvement of Investment Climate under the President of the Republic of Tajikistan and noted that the purpose of the workshop is to strengthen public-private partnerships and exchanges of views between partners.

Also the Deputy Chairman of the State Committee on Investments and State Property Management of the Republic of Tajikistan had a introductory speech at the seminar.

Particularly ways of improvement of coordination of mutual cooperation in regard with preparation of proposals and recommendations to the Consultative Council on Improvement of Investment Climate under the President of the Republic of Tajikistan and regional consultative councils, conducting analysis and evaluation of proposals on improvement of investment and business climate for the sessions of the consultative councils of national and regional levels (a filtration process), monitoring of implementation of decisions made by Councils of national and regional levels, as well as their activities' information support have been proposed. submitted issue on improvement of investment climate in agriculture sector of Rasht Valley for consideration to the next meeting of the Council that was supported by all members of the Council.

At the completion of the meeting relevant instructions was given by Qodiri Qosim – Chairman of the Consultative Council on Improvement of Business and Investment Climate in Rasht Valley to responsible region departments of ministries and agencies on issues considered at the meeting.

Particularly, action plan on improvement of investment climate in tourism of Rasht Valley was approved taking into account opinion of participants and was sent for the implementation to executive government authorities of the regions of Rasht Valley.

Secretariat of the regional Council was instructed to establish a working group from among the representatives of local authorities of relevant ministries and agencies, private sector with assistance of development partners in cooperation with executive government authorities of the districts of Rasht Valley for the purpose of development of agriculture in the region and revealing ways of problems' solution in the region and to conduct analyses of agricultural sectors in Rasht Valley.

Results of analyses with comprehensive recommendations on improvement of investment climate in agricultural sector should be submitted to subsequent session of the Council.

PREPARATION WORKS FOR THE MEETING OF THE PRESIDENT OF THE REPUBLIC OF TAJIKISTAN WITH ENTERPRENEURS AND INVESTORS AND ECONOMIC AND INVESTMENT FORUM DUSHANBE – 2014

It should be noted that more attraction of investment and business development through improvement of investment and business climate as well as making appropriate them with international standards' requirements are key priorities of the economic and social policy of the Government of the Republic of Tajikistan.

Based on this, according to the instruction of the President of the Republic of Tajikistan during the 13th Session of the Consultative Council on Improvement of Investment Climate under the President of the Republic dated on May 30, 2014 a Meeting of the President of the country with Entrepreneurs and Investors will be held on October 15-17, 2014. In the framework of this meeting a range of events, including Economic and Investment Forum Dushanbe-2014 will host with participation of representatives of international finance organizations, entrepreneurs and investors.

The main objects of conduction of this meeting and Economic and Investment Forum are facilitate improvement of investment and business climate and attraction of more

investments to the national economy, arrangement of cooperation and partnership among the national and foreign entrepreneurs and investors in prioritized sectors of economics such as energy, industry, infrastructure, banking, finance, agriculture and tourism that oriented on technical and technological modernization of industrial manufactures, complete processing of local raw material, production of competitive and meeting international standards final products as well as development of export capacity of the economy.

It is expected to conduct following actions in the framework of the Meeting of the President of the country with entrepreneurs and investors:

First day: Meeting of the President of the country with entrepreneurs and investors, exchange of views and awarding honored entrepreneurs and investors.

Second day: Conducting Economic and Investment Forum Dushanbe - 2014 with participation of representatives of the international financial organizations, entrepreneurs and investors. In this forum, a range of economic issues such as investment and entrepreneurship, industry, agribusiness, infrastructure, finance and banking in the Republic of Tajikistan would be considered in separate sections.

Main issues of Economic and Investment Forum Dushanbe - 2014:

- I. Social- economic aspects of sustainable development;
- II. Investment, innovations and infrastructure;
- III. Development of sustainable financial system;
- IV. Foreign trade development and increasing competitiveness of national economy.

Third day: Conducting National Development Forum with participation of representatives of international financial organizations and presentations of results of the meeting of the President of the country with entrepreneurs and investors.

Currently, Secretariat of the Consultative Council on Improvement of Investment Climate under the President of the Republic of Tajikistan jointly with State Committee on Investment and State Property Management of the Republic of Tajikistan have been implemented following works with purpose of conduct the Meeting of the President of the Republic of Tajikistan with entrepreneurs and investors in a high level:

- A Draft Action Plan on conduction of Meeting of the President of the Republic of Tajikistan with entrepreneurs and investors was developed and sent to the Executive Office of the President of the Republic of Tajikistan;

During the Round Table the issues of survey by Doing Business Report of the World Bank in 2014, implemented reforms and achievements of the Government of the Republic of Tajikistan on improvement of investment and business climate which promote to improve country indicators in the Doing Business Report were considered and discussed.

This Mission was consist from International Expert Julian Levis – Doing Business Advisor of the World Bank, Periklis Saragiotis and Gagi Gabrielyan – Private Sector Development, Trade Logistics, Trade and Investment Climate Specialists of the World Bank on Doing Business.

A Mission of the World Bank together with representatives of Secretariat of the Consultative Council and State Committee on Investment and State Property Management of the Republic of Tajikistan had a meetings with representatives of a range of ministries and agencies, particularly Ministry of Economic Development and Trade, State Committee on Land Management and Geodesy, Committee of Construction and Architecture, Tax Committee, Tojikstandart Agency, Custom Service and National Bank of Tajikistan.

During the meetings with responsible persons of state authorities, last reforms and achievements in relevant sectors regarding improvement of Tajikistan's indicators in the Doing Business Report of the World Bank was considered and discussed.

In the completion of the meetings on May 4 a video conference was conducted in the IFC Office in which Mission of World Bank together with representatives of Secretariat of the Consultative Council and State Committee on Investment and State Property Management of the Republic of Tajikistan, Representation of IFC Office in Tajikistan and Expert of Doing Business Team – Ms Iva Hamil from central Office of World Bank in Washington discussed and talked on implemented reforms in Tajikistan regarding improvement of country' indicators in this report.

Particularly reforms regarding establishment and fully implementation of "One Stop Shop" for registration of entrepreneurs' entities under the Tax Committee, "Single Window" for connections with the engineering system under the Committee of Construction and Architecture, establishment of SUE "On Real Estate Registration" under the State Committee on Land Management and Geodesy on base of merging of SUE "Markaz-Zamin" and SUE "State Land Use" Committee affiliate with implementation of "Single Window" for state registration of real estate, development and acceptation of draft Law of the Republic of Tajikistan "On Introduction amendments and modifications to the Law of the RT "On Pledge of Movables» in the framework of activity of the Working Group on improvement of investment climate under the National Bank, implemented reforms on reducing of number of taxes and tax administrations simplification, "Single Window" system on export and import procedures and transit under the Custom Services were noted.

It should be noted that World Bank Mission and Team of the Doing Business Report of the World Bank highly appreciated with reforms and country's achievements on improvement of business and investment climate, as well as operation of state bodies on process of implementation of this reform.

ACTIVITY OF THE WORKING GROUP ON DEVELOPMENT OF SECONDARY MARKET FOR SECURITIES AND ESTABLISHMENT OF A STOCK EXCHANGE MARKET

It should be noted that in the base of protocol instruction of 12th Session of the Consultative Council on Improvement of Investment Climate under the President of the Republic of Tajikistan a National Bank was instructed jointly with Ministry of Finance, Trade and Economic Development, State Committee on Investment and State Property Management to establish a Working Group consisting from representatives of relevant ministries and agencies, private sector by involving development partners and to conduct analysis regarding development of secondary market for securities and stock exchange market as well as submit their results with comprehensive recommendations to the subsequent sessions of the Council.

For the implementation of this instruction a Working Group was established under the leadership of First Deputy of Chairman of the National Bank in the base of Order of Chairman of National Bank on December 29, 2013.

Up to this day the Working group conducted 5 meetings on which a range of issues, as well as legal regulatory acts of activity of secondary market and their contradictions, main factors impeding development of secondary market and ways of their revealing and elimination, simplification of listing procedure in first steps of development of secondary market, establishment of electronic unified registry for securities and etc. have been considered by members of the Working Group.

The Working Group would submit a Report and draft Action Plan of the Government of the Republic of Tajikistan for development of secondary market for securities to the 14th Session of the Consultative Council.

REFORMS ON IMPROVEMENT OF INVESTMENT AND BUSINESS CLIMATE IN INSURANCE SECTOR

It should be noted that in concern with improvement of investment and business climate in insurance sector the intermisterial Working Group under the Ministry of Trade and Economic Development of the Republic of Tajikistan with participation of representatives of relevant ministries and agencies, private sector and with support of development partners completed its activity. The results of its activity has been prepared as a Report with comprehensive recommendations. On the base of Report and proposed recommendations a draft Action Plan of the Government of the

Republic of Tajikistan on improvement of investment climate in insurance sector has been developed and presented jointly with the Report of the Working Group in 13th Session of the Consultative Council dated on May 30, 2014.

Regarding this, Ministry of Trade and Economic Development of the Republic of Tajikistan was instructed to improve draft Action Plan of the Government of the Republic of Tajikistan on improvement of investment and business climate in insurance and submit for the consideration of the Government of the country in accordance with defined procedure.

Ministry of Trade and Economic Development improved a draft Action Plan of the Government of the Tajikistan on improvement of investment and business climate in insurance and coordinated it with relevant ministries and agencies. Presently this Action Plan was sent for consideration of the Government of the country.

Also with the purpose of implementation of protocol instruction of 13th Session of the Consultative Council an interministerial Working Group was established on development of regulatory legal documents of the insurance sector in comply with insurance international standards and are being operated under the Ministry of Trade and Economic Development of the Republic of Tajikistan. In the framework of activity of the Working Group a draft Law of the Republic of Tajikistan "On Insurance Activity" in a new edition should be developed and sent for the consideration of the Government of the country in accordance with defined procedure.
